License conditions

§2 The SOFTWARE is protected by copyright laws and international copyright agreements, as well as other intellectual property laws and agreements. No part of the SOFTWARE or the manual may be multiplied, disseminated or processed in any way without the written consent of CARDWERK. Violations of these conditions will be prosecuted in every case.

§3 The use of the SOFTWARE is done at your own risk. CARDWERK accepts no liability for any damages, either as direct or indirect consequence of the use or abuse of this product or software. The SOFTWARE is being licensed and not sold.

§4 You may not reverse engineer, decompile, or disassemble the SOFTWARE or any assemblies downloaded with SmartCardAPI (Professional) software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

SOFTWARE may contain components for third-party smart cards. Such card software modules may contain cryptographic key material or confidential data. You may not reverse engineer, decompile, or disassemble such CardModule under any circumstances.

- The runtime files may only be redistributed with applications that add considerable functionality to the CardWerk SmartCard API.

- The source code must not be redistributed or disclosed to third parties in any way.

This is in order to clearly distinguish modified files from the original files.

- Redistribution within products distributed to and used by software developers to integrate chip cards or readers is prohibited

- DataModule.xyz assemblies are excluded from source code license; only available as binaries
- ReaderModule.xyz assemblies are excluded from source code license; only available as binaries
- SecurityModule.xyz assemblies are excluded from source code license; only available as binaries
